PART I: SECTION (I)—GENERAL

Government Notifications

THE MERCHANT SHIPPING ACT, No. 52 OF 1971

Regulations made by the Minister of Trade and Shipping by virtue of the powers vested in him by sections 44 and 321 of the Merchant Shipping Act, No. 52 of 1971.

Regulations

- 1. These regulations may be cited as the Merchant Shipping (Registration of Sri Lankan Ships owned by Sri Lanka Companies with Foreign Shareholders) Regulations, 1983.
- 2. (a) These regulations shall apply to any ship which is owned wholly by a Company incorporated in Sri Lanka with Foreign shareholders and seeking registration under the Sri Lanka Register with off-shore status.
- (b) The provision of the Fisheries (Regulation of Foreign Fishing Boats) Act, No. 59 of 1979, shall apply to ships registered under these regulations, and the registration of ships under these regulations shall not entitle such ships to the rights and privileges afforded to ships registered under the Fisheries Ordinance.
- 3. Every application for provisional or permanent registration of a ship referred to in regulation 2 shall be made substantially in the form set out in Schedule I hereto to the Registrar of Sri Lankan Ships or to any accredited officer whose name and address is set out in Schedule II hereto in triplicate.
- 4. Ships which have passed their twentieth year from completion of first construction shall not be eligible for registration unless specifically authorized by the Chief Registrar of Ships.
- 5. All documents necessary for the registration of a ship as indicated in paragraphs 10 and 11 to be submitted along with the application.
- 6. All oaths required to be made under the Act shall be made before any of the following persons:—
 - (a) the Registrar of Sri Lankan Ships;
 - (b) the Sri Lanka Consul or a consular officer;
 - (c) any other person specifically authorized in writing in that behalf by the Reistrar of Sri Lankan Ships for the administration of such oath.

- 7. No ship shall be registered unless at the time of registration such ship is classed by one of the following classification Societies:
 - (1) American Bureau of Shipping;
 - (2) Bureau Veritas;
 - (3) Des Morske Veritas;
 - (4) Germanischer Lloyd;
- (5) Lloyds Register of Shipping;
 - (6) Nippon Kairi Kyokai;
 - (7) Polish Register of Shipping;
 - (8) Register of Shipping of the People's Republic of China;
 - (9) The U.S.S.R. Register of Shipping;
 - (10) Deutsche Schiffs-revisions; and Classification Geselschaft.
- 8. Certificates required to be issued under the provisions of international conventions ratified by Sri Lanka or any other Certificate the Chief Registrar of Ships may require shall be issued by one of the Classification Societies listed in regulation 7.
- 9. The registration fee and tonnage tax as specified in Schedule III hereto, are payable in advance in U.S. Dollars or other convertible currency without any deduction.
- 10. The requirements for provisional registration of a ship which shall be valid for a period of six months shall be as follows:
 - (1) an application for official number, call sign and registration of vessel;
- (2) the consent of the country of current registry to transfer such registry to Sri Lanka;
 - Provided that, this requirement may be waived if the cancellation certificate is submitted to the Registrar of Sri Lankan Ships;
 - (3) the original Bill of sale, and in the case of a new ship the Construction Certificate and other documents in proof of ownership;
 - (4) Proof of ownership where the applicant owns a ship under a foreign flag and transfers it to the Sri Lankan flag without any change in ownership;
 - (5) where a mortgage transaction takes place the name of the mortgagee, the amount of the mortgage, the discharged amount of the mortgage and the date of maturity;

- (6) certified copies of the resolutions of the Board of Directors and the power of attorney given to the accredited officer or agent of the buying and selling company;
- (7) a statement of the number of shares in the ship;
- (8) the name of the Master and his citizenship;
- (9) a declaration made by the applicant that to the best of his knowledge and belief no unqualified person or body of persons is entitled as owner to any legal or beneficial interest in the ship or to any share therein;
- (10) the Certificate of Confirmation of Class or the Certificate of Seaworthiness issued by the Classification Society with which the ship is classed and such Certificate shall be dated not more than fourteen days prior to the date of application for registration;
- (11) where a ship is being transferred from a foreign registry, a certificate issued by a Government Department that such ship is free from lien;
- (12) a certificate of good standing issued by the authority of the government or country where the company has been incorporated, relating to the name, the present directors and shareholders of such company, legal existance, and present good standing of such company;
- (13) a certificate of good standing issued by the Registrar of Companies of Sri Lanka relating to the name of the company, the Chairman or Manging Director and other directors and shareholders of such company legal existance and present good standing of such company;
- (14) the payment of the registration fees specified in the Regulations published in Gazette No. 173/2 dated December 28, 1981;
- (15) a Power of Attorney or a Secretary's Certificate of Corporate Resolution, authorising one or more persons to act for or on behalf of the applicant in making an application for registration of a ship and to do all acts necessary to register such ship;
- (16) where a ship is being transferred from a foreign registry a certificate or other document which would be acceptable to the Registrar of Sri Lankan Ships as proof of cancellation of such ship from such foreign registry.

- 11. The requirements for permanent registration of a ship which shall be valid for a period of four years shall be as follows:
 - (1) a certificate of Class Maintenance issued by any one of the Classification Societies listed in regulation 7;
 - (2) Sri Lankan Load Lines Certificate issued under the provisions of the International Load Lines Convention;
 - (3) Sri Lankan Cargo Ships Safety Equipment Certificate issued under the provisions of the International Convention for the Safety of Life at Sea 1960;
 - (4) Sri Lankan Cargo Ship Safety Radio Telegraphy Certificate issued under the provisions of the International Convention for the Safety of Life at Sea 1960;
 - (5) Sri Lankan Passenger Ship Certificate required for passenger ships only and issued under the provisions of the International Convention for the Safety of Life at Sea 1960;
 - (6) a sworn notarised statement by the applicant or his authorised agent or Master of the ship to the effect that the markings required under section 39 of the Sri Lanka Morchant Shipping Act, No. 52 of 1971 have been complied with;
 - (7) certificate of Good Standing of the company shall be submitted every year not later than January 30 of such year;
 - (8) names of shareholders of the Company and the number of shares held by each shareholder;
 - (9) a list containing the names, nationalities and certificates of the Master, officers and crew;
 - (10) an application for a radio licence containing the relevant data:
 - (11) name of the company with which a contract has been signed in respect of radio equipment;
 - (12) an undertaking to inform the Registrar of Sri Lankan Ships of any change in the particulars given in the application Form.
 - 12. In these regulations-

"the Act" means the Merchant Shipping Act, No. 52 of 1971.
