All Container Operators are required to comply with all appropriate provisions as specified in the regulation bearing government gazette notification extraordinary No. 1402/19 dated 22nd July 2005 promulgated under the Licensing of Shipping agents, Freight Forwarders, NVOCC Operators and Container Operators Act No 10 of 1972 as amended, and submit all relevant documents together with duly filled application to the Merchant Shipping Secretariat (MSS) on or before **15th November 2023**, for renewing of the license.
